Welcome to Tabletennis club Maastricht!

In this leaflet you find some information about our club and a registration form.

General information:

Table Tennis Club Maastricht (TTV Maastricht) was established on the 1st July in 1967, and so has been in existence for more than 50 years. It is a sociable club with active members ranging from 6 to 75 years of age.

TTC Maastricht is affiliated with the Dutch Table Tennis Association (NTTB) and has teams competing at both junior and senior levels within the Limburg's division of this association. You can find more information about our club on our web site: www.ttvmaastricht.nl

Membership:

To get to know our club you are welcome to come and use our facilities a couple of times for free, as a non-member. See opening times below. We would like, however, to note your name so that we know who is our guest in any event. If you wish to join our club, then please fill in the attached registration form. The club year runs from 1st July to 30th June. Membership can only be terminated by requesting this in writing (or email) at least one month prior to the end of the club year.

	for seniors (above 18 years old)	€ 175.00 per year
	for seniors 65+	€ 165.00 per year

It is possible to pay on a quarterly basis but this incurs a quarterly administrative cost of € 2.00.

The quarters run from 1/7 to 30/9, 1/10 to 31/12, 1/1 to 31/03 and from 1/4 to 30/6. Subscriptions need to be paid into our account before the beginning of each quarter.

An extra payment is required if you participate in a competition team. This payment should be made to the club which will then pay the competition subscription to the NTTB.

Privacyverklaring

This is the privacy statement of T.T.V. Maastricht, located in Maastricht, registered in the trade register of the Chamber of Commerce under number 40203811, hereinafter referred to as: 'T.T.V. Maastricht'. Consciously or unconsciously, you share personal data with us. We consider it important that your personal data is handled with care. Therefore, in this statement, we have set out for you how we handle your personal data and what rights you have. T.T.V. Maastricht does not use your data for any purpose other than what is desirable and necessary for the proper functioning of the association. In the overview below, you can quickly and easily find out for what purpose we collect which personal data from you, how long we keep this data, and who may receive this personal data from us.**Execution of the membership agreement**

If you become a member, we register your first and last name, address, date of birth, telephone number(s), email address, an NTTB number, for seniors the affinity with types of volunteer work, for youth members the address details of parents and/or guardians. During the membership, images and performance data are collected on a small scale. This data is available within the association for membership administration, the secretariat, and/or volunteers who organize activities (such as bar services). Outside the association, the data is made available to the NTTB and, if necessary, to subsidy providers (e.g., the municipality). We keep the data as long as you are a member and participate in any committees, and for some parts also from former members (see point 5).

Administration

In addition to the above data, your bank and payment details are recorded. These are accessible to the financial administration. This data is kept according to legal terms (currently for the financial administration for 7 years)

PR and communication

To inform you and others about activities and developments of T.T.V. Maastricht, we send newsletters, post messages on our website and on social media, etc. Where necessary and relevant, we only publish your name and images with your explicit consent. Upon registration or via a later provided consent form, you can indicate whether or not you agree with this.

Website

Every time you visit our website, cookies are placed to improve our digital services. The data is analyzed anonymously. The use of this data is strictly functional, and you do not have to give permission for this each time.

After termination of membership

If you are no longer a member, your contact details, as well as existing images and performance records, are kept for special events, reunions, etc. This material is available to the membership administration, the secretariat, and, for example, a reunion committee.

Cookies

A cookie is a small text file that is sent along with the pages of a website and stored by the browser on your computer, tablet, or mobile phone. We use cookies to provide you with more service when visiting our websites, making them easier to use. Cookies, for example, ensure that you can stay logged in to a website or that your preferences, such as location and language settings, are remembered. Thanks to cookies, we can see how often our websites—and which pages—are viewed by visitors. For certain cookies, you must first give permission before these cookies may be used. Provision of personal data to third parties Without your consent, the Association only provides your personal data to third parties if this is necessary or if the Association is legally obliged to provide your personal data to these third parties. Access, correction, and deletion of personal data

You have the right to request the Association to access your personal data (unless the Association is not obliged to provide this access under the General Data Protection Regulation (GDPR)) and to have your data supplemented, deleted, or blocked. You must identify yourself for such a request. If you wish your data to be deleted, the Association will pass on this deletion to all other organizations that have received the relevant data from the Association.

Security of personal data

The Association takes appropriate measures to protect your personal data as well as possible against loss, unauthorized access, publication, and unlawful processing. We strive to ensure that only the necessary persons have access to your data, that access to personal data is shielded, and that our security measures are regularly checked.

Minors

If you wish to register as a minor, you must provide explicit permission from your parent or guardian.

Links to other websites

The website may contain links to other websites. This Privacy Statement only applies to the Association's websites. Other websites may have their own privacy policies. The Association advises you to always consult the privacy statement of those websites before using other websites.

Changes to the privacy policy

The Association adjusts its privacy policy from time to time to keep it up to date. The most recent version of our Privacy Statement will always be included on the websites. The Association therefore advises you to consult the Privacy Statement regularly. In case of important changes, the Association will do everything possible to inform you by email and via the websites.
